RE: Internal Investigation

Chief Deputy Fullen,

I was recently made aware of accusations brought against you that prompted me to launch an investigation to discover the validity or lack thereof to these allegations. You have been publicly accused of two separate issues concerning your TCOLE (Texas Commission on Law Enforcement) training credentials/license as well as you being on a "Brady List" from 1989 which places your and this office's integrity into question.

In addressing the first issue of training requirements with TCOLE, there was a delay in your requirements being met due to your resignation as Constable and being unaware that you then fell into the requirements as a deputy. However, in an email you received from Major Vineyard, with TCOLE Enforcement Division, dated October 5th, 2023, he mentions that since you were not notified of your training deficiencies, the Interim Executive Director was willing to grant you until the end of October to get into compliance. You immediately rectified the training issue within days and are now in complete compliance with TCOLE as of 10-07-23. Further your status has been changed from "Constable" to "Peace Officer" on the TCLEEDS (Texas Commission on Law Enforcement Data Distribution System) website.

On the issue of you being accused of being on a "Brady List" or being a "Brady Officer", I have in my possession an email from Galveston County District Attorney, Jack Roady, dated October 25th, 2023. Mr. Roady explained Brady v. Maryland in detail and has searched their (Galveston Co DA's Office) database relating to any circumstance surrounding the Brady accusation and found no such information pertaining to you.

I received an email from Major Vineyard on October 27th, 2023 pertaining to the allegation that TCOLE has you listed as a "Brady Officer". Major Vineyard advised that TCOLE does not maintain Brady lists and does not have anything to do with Brady disclosures.

Since the accusation stems from your time as a police officer in Electra, TX, Wichita County, in 1989, I emailed the First Assistant DA, Dobie Kosub, as the DA, John Gillespie, was in trial and unavailable, to inquire if you were on any database in that county that would possibly list you in a "Brady" status.
